ARPC provides reinsurance cover to more than 230 insurers who themselves insure more than \$3.6 trillion in sums insured. While the Terrorism Insurance Act 2003 mandates that insurers provide cover for terrorism, it is voluntary for insurers to buy reinsurance from ARPC. Insurers who enter into a reinsurance contract with ARPC lay off their terrorism liability to ARPC and their eligible insurance contracts are protected through ARPC's net assets, global retrocession program and the Commonwealth guarantee.
