Freedom of Information

Freedom of Information (FOI)

The objective of the Freedom of Information Act 1982 (FOI Act) are to provide access to, and encourage proactive disclosure of, information created and held by the Commonwealth Government and its agencies.

FOI requests (FOI)

- Under the FOI Act, you can request access to Agency documents by making a Freedom of Information request (FOI request).
- Requests for information must be in writing (can be emailed); state that it is an application under the FOI Act; provide a return address; and be sent to ARPC. Requests can be made anonymously or under a different name.
- ARPC needs to acknowledge that it has received the request within 14 days of receipt and must respond to requests within 30 days of the receipt of request with either a granting or refusal of the request. The time to decide can be extended upon agreement, to allow ARPC to consult a third party, if the request is too complex or large, or if charges have not been paid.
- ARPC may impose a reasonable charge on an FOI applicant in accordance with the FOI Act and Charges Regulations.

Information Publication Scheme (IPS) and Agency Plan



The Information Publication Scheme (IPS) has been established under *Freedom of Information Act 1982* (FOI Act). The IPS requires Australian Government Agencies to publish a broad range of information on their websites and to have a published an [Agency Plan](#) to explain how the IPS is administered.

The Agency Plan describes what information ARPC will publish; how it will publish this information; and how it will comply with the requirements of the IPS, as required by s 8(1) of the FOI Act.

Public Interest Disclosure

The *Public Interest Disclosure Act 2013* (PID Act) promotes integrity and accountability in the Australian public sector by encouraging the disclosure of information about suspected wrongdoing. It protects public officials who make disclosures and requires that agencies take action. The emphasis of the scheme is on disclosures being made and investigated within government. The PID Act is not intended to replace existing processes for dealing with workplace grievances and misconduct, such as bullying and harassment, but rather to supplement them.
