#### **ARPC hosts Terrorism Risk Insurance Seminar**

ARPC held its annual Terrorism Risk Insurance Seminar at Parliament of NSW on 20 November. Industry experts shared their views on the complexity and evolving nature of terrorism risk and the importance of fostering a culture of preparedness.

The seminar featured experts in terrorism risk, including:

**ASIO** on the Annual Threat Assessment.

**Dr David Hammond** – Director of Research, Institute of Peace and Economics presented how research can be used to show that peace is a positive and achievable measure of wellbeing and development.

**Paul Henry** – Inspector, Fixated Threat Assessment Centre, Counter Terrorism Command, Victoria Police shared the coordinated approach required to respond to serious threats of violence that could result in terrorism or perpetration of violence.

**Dr Christopher Wallace** – Chief Executive, ARPC discussed the role ARPC plays in addressing terrorism risk.

Australia's official tropical cyclone season runs from now until 30 April 2025.

The start of the cyclone season is an opportunity for our cedants to confirm that the correct person is receiving declared cyclone notifications.

# ARPC enters partnership for a 3-year program of research on cyclone resilience with the University of Queensland

ARPC has partnered with the University of Queensland for a program of research on cyclone resilience. The research will be conducted over three years as part of ARPC's delivery of thought leadership.

The aim of the program of research is to understand how insurance risk pooling can support individual and community resilience to cyclones, to improve community outcomes for the cyclone reinsurance pool.

The first 12 months of the program will begin with a review of the resilience implications of insurance risk pooling at both individual and community levels in other peer countries. The analysis will inform the subsequent two years of in-field research.

### Are you ready for the PACE portal?

ARPC Terrorism Pool is moving from RISe to a new portal called PACE.

RISe will accept premium submissions up until 30 January 2025, however, after that date, insurers will have to submit them via the PACE portal.

ARPC's Terrorism Pool team will hold two webinars to demonstrate PACE:

- Thursday January 16 2025, 2:00 PM -3:00 PM (UTC+11:00) Canberra, Melbourne, Sydney
- Wednesday January 22 2025, 7:00 PM -8:00 PM (UTC+11:00) Canberra, Melbourne, Sydney

Insurers will be able to submit questions in the webinar chat, or if you prefer, you can email your questions in advance.

Members of your team who currently use RISe to submit premium or annual aggregate submissions should attend a webinar so they can learn to use PACE.
